



All projects for which a GAF enhanced warranty or guarantee is requested must be supervised by a foreman who has passed the applicable self-administered examination for the appropriate roofing system to which the Guarantee applies, and prior to your initial installation of a GAF roofing system, as applicable, you must schedule and attend a training session conducted by GAF authorized personnel.

WellRoof® Guarantee Extension

If you are a GAF Commercial Chairman’s Circle Contractor or a GAF PlatinumElite™ Commercial Contractor, you must perform annual inspections and maintenance on all roofs on which a GAF WellRoof® Guarantee Extension (the “WellRoof® Extension”) is registered by you during the first two years after guarantee issuance. Such annual inspection and maintenance will include, at a minimum: (i) performing all items listed on the “Roof Maintenance Program” checklist provided by GAF, as the same may be modified by GAF from time to time in its sole discretion; (ii) submitting roof audit/inspection reports in the format developed by GAF, as the same may be modified by GAF from time to time in its sole discretion; and (iii) submitting photographs of the roof in a format approved by GAF to evidence your satisfaction of your annual inspection and maintenance

obligations. A WellRoof® Extension will not be effective if you have failed to perform any of the requirements set forth herein. GAF reserves the right to cancel any WellRoof® Extension registered by you if you fail to comply with the requirements herein or in any other documentation related to the Well Roof® Extension.
