THE WARRANTY

GAF warrants to you, the original owner of the property described above, that subject to the conditions and limitations of this Limited Warranty, products sold under the StreetBond® brand (the "StreetBond® Products") will not contain a manufacturing defect that adversely affects performance through the Expiration Date listed above as long as the StreetBond® Products were installed on a sound pavement substrate, during the shelf life set forth on the product label or container.

CONDITIONS TO WARRANTY COVERAGE

- 1. Applicator:** The StreetBond® Products must be installed by a GAF Authorized Applicator or GAF Master Applicator in accordance with the current GAF published application instructions.
- 2. Registration:** This Limited Warranty must be registered in accordance with GAF registration requirements.

EXCLUSIVE REMEDY

GAF's sole responsibility for breach of this limited warranty is to provide replacement material for that portion of the StreetBond® Products that peel, delaminate, or show abnormal wear, or at GAF's sole option the cash value of said StreetBond® Products. Decisions as to the extent of replacement required will be made solely by GAF. The remedy under this Limited Warranty is available only for that portion of the StreetBond® Products actually peeling, delaminating, or showing abnormal wear at the time of settlement. The replacement StreetBond® Products, as well as any remaining original StreetBond® Products, will be warranted only for the remainder of the original warranty period.

NOTIFICATION OF CLAIM

In the event that your StreetBond® Products peel, delaminate, or show abnormal wear, you **MUST** notify GAF in writing — either by email (preferred) at guarantee@laf.com or by postal mail to GAF Guarantee Services, One Campus Drive, Parsippany, NJ 07054 — **and** provide proof of purchase, lot numbers, and application date to establish that you are the original owner within **30 days** after your discovery of the issue. **NOTE:** Notice to your applicator or distributor is **NOT** notice to GAF. Within a reasonable time after proper notification, GAF will evaluate your claim and resolve it in accordance with the terms of this warranty. GAF may require you to submit, at your expense, samples of your StreetBond® Products for testing and photographs. You should retain this document in the event that you need to file a claim.

EXCLUSIONS FROM COVERAGE

This Limited Warranty does NOT cover damage to the StreetBond® Products resulting from anything other than an inherent manufacturing defect in the StreetBond® Products, including but not limited to:

NON-ASSIGNABILITY

This Limited Warranty is NOT TRANSFERABLE OR ASSIGNABLE by contract or by operation of law, either directly or indirectly.

LIMITATION OF DAMAGES; MEDIATION; JURISDICTION; CHOICE OF LAW

THIS WARRANTY IS EXPRESSLY IN LIEU OF ANY OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE, and of any other obligations or liability of GAF, whether any claim against it is based upon negligence, breach of warranty, or any other theory. In NO event shall GAF be liable for any CONSEQUENTIAL OR INCIDENTAL DAMAGES of any kind, including, but not limited to, interior or exterior damages and/or mold growth.

The parties agree that, as a condition precedent to litigation, any controversy or claim relating to this warranty shall be first submitted to mediation before a mutually acceptable mediator. In the event that mediation is unsuccessful, the parties agree that neither one will commence or prosecute any lawsuit or proceeding other than before the appropriate state or federal court in the State of New Jersey. This warranty shall be governed by the laws of the State of New Jersey, without regard to principles of conflicts of laws. Each party irrevocably consents to the jurisdiction and venue of the above identified courts.

NOTE: Some states do not allow limitations on or the exclusion of incidental or consequential damages, so the above limitations or exclusions may not apply to you. This Limited Warranty gives you specific legal rights and you may also have other rights which vary from state to state.

NOTE: This Limited Warranty becomes effective only when all bills for installation and supplies have been paid in full to the applicator and materials supplier.

This Limited Warranty must have a raised seal to be valid.
