DETAIL A COURSE LAYOUT

SHINGLE INSTALLATION

Start at either rake and lay in either direction

First Course:

Start with full shingle

Second Course:

Trim 10" (254mm) off first shingle

Third Course:

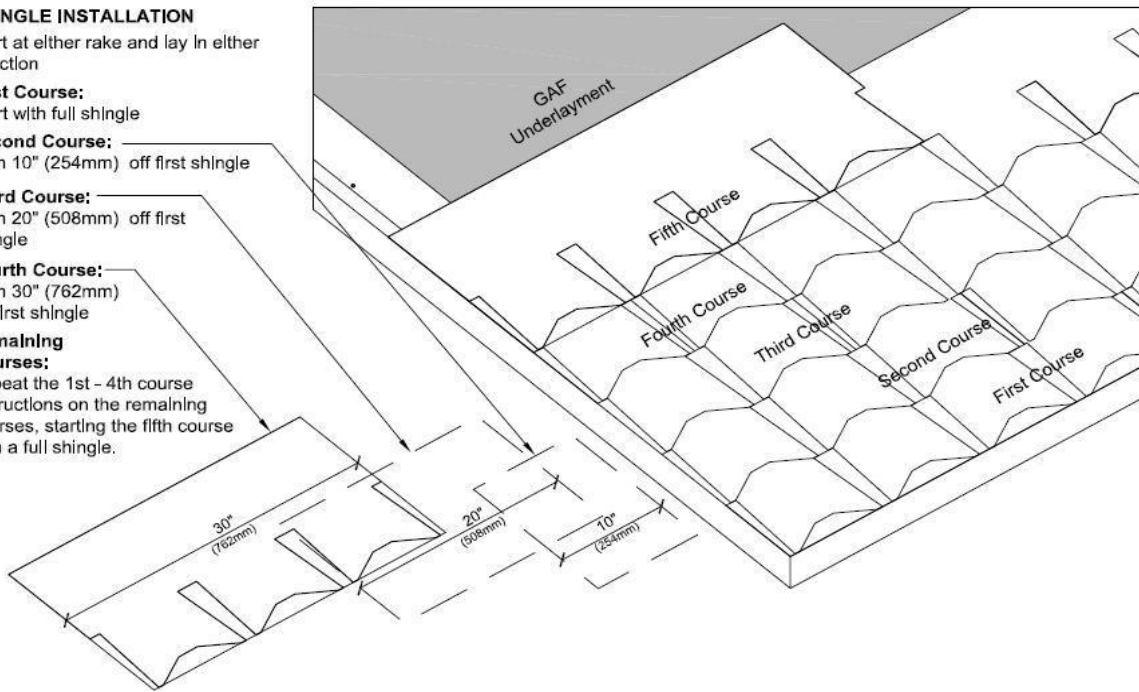
Trim 20" (508mm) off first shingle

Fourth Course:

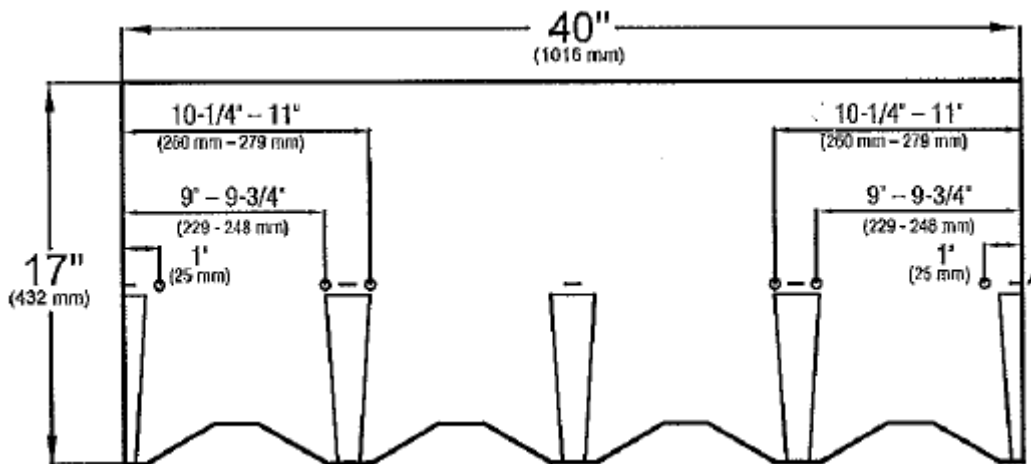
Trim 30" (762mm) off first shingle

Remaining Courses:

Repeat the 1st - 4th course instructions on the remaining courses, starting the fifth course with a full shingle.
