ACKNOWLEDGEMENT OF GAF REQUIREMENTS FOR INSTALLATION OF A PHOTOVOLTAIC SYSTEM ON A GUARANTEED ROOF SYSTEM

In order to obtain or maintain coverage of your roof under a GAF guarantee when installing a photovoltaic (PV) system, you must meet the requirements and follow the process outlined below.

REQUIREMENTS:

- 1. Complete and sign this form** and submit it to GAF Guarantee Services guaranteeservices@gaf.com at least 30 days prior to installation of the PV system. Include with submission the following items:
 - a. Shop drawings** of the PV system layout and the total roof plan.
 - b. All flashing details** that will be used to install the PV system.
 - c. \$600** for pre-installation inspection.
\$600 for post-installation inspection.
- 2. For new construction only, the final inspection of the GAF roofing system MUST be completed prior to the installation of the PV system** or guarantee issuance may be jeopardized. Additionally, all punch list items identified at the final inspection must be completed before installation of the PV system and certification or documentation of repairs (as appropriate) must be submitted to GAF.
 - 2a.** For existing GAF-guaranteed roofing systems (6 months or older) a pre-installation inspection of the GAF roofing system MUST be completed prior to the installation of the PV system. Additionally, all punch list items identified at the pre-installation inspection must be completed before installation of the PV system and certification or documentation of repairs (as appropriate) must be submitted to GAF.
 - 2b.** For newly installed GAF roofing systems (6 months old or less), the final inspection of the GAF roofing system MUST be completed prior to the installation of the PV system or guarantee issuance may be jeopardized. Additionally, all punch list items identified at the final inspection must be completed before installation of the PV system and certification or documentation of repairs (as appropriate) must be submitted to GAF.
- 3. All flashing details and any other roofing work must be completed by a GAF GoldElite™ or PlatinumElite™ Roofing Contractor.**
For roofs under 2 years old, this work should be done by the original installing contractor.
- 4. Contact GAF Guarantee Services at 877-423-7663, Option 3, after the PV system installation and all flashing work is completed to schedule a post-installation roof inspection.** Note: This inspection will not be scheduled unless/until the inspection fee is paid to GAF.
- 5. Complete any required repairs,** including repairs to flashing details that are not acceptable and repairs to the GAF roofing system for damage that occurred during the PV system installation. GAF reserves the right to require additional inspections as necessary to ensure that all GAF requirements outlined above are met. The fee for any reinspection is \$600.
- 6. After all requirements are met and fees paid, GAF will issue an addendum to the guarantee confirming coverage for leaks under the terms and conditions of the guarantee.**

OWNER ACKNOWLEDGEMENT AND AGREEMENT

Upon notification from GAF, you agree to remove and replace the rooftop PV system at the above-referenced project, at your expense, to provide access to the roofing system for GAF to conduct a leak investigation and/or to make covered repairs to the roofing system. You agree to be responsible for all costs associated with the removal and replacement of the PV system regardless of whether the resulting repair work is covered by the GAF Guarantee. GAF is not responsible for any changes or alterations in either the appearance or the performance of the roofing system as a result of the removal and replacement of the PV system.
2. You further agree that all electricity connected with the PV system will be rendered inoperable, at your expense, prior to GAF conducting a leak investigation and/or making covered repairs to the roofing system, and shall remain so until the investigation and/or repair work is fully completed. You understand and acknowledge that GAF is not responsible for any loss (loss of income, building use, etc.) or damages (consequential, direct or indirect) which may result from rendering the photovoltaic system inoperable.
3. In the event of any damage to the roofing system during the installation, removal, or replacement of the PV system, you agree to have the roof repaired by a GAF GoldElite™ or PlatinumElite™ Roofing Contractor. For roofs under 2 years old, this work should be completed by the original installing contractor.
4. You understand and agree that the GAF Guarantee does not cover any leaks, changes in appearance, damage, or loss of performance in the roofing system resulting from the installation, operation, or the presence of a PV system. You further understand and agree that GAF is not responsible for any claims that are attributable to the PV system.
5. You acknowledge that you have read and understood GAF's recommendations for the installation of PV systems, available at gaf.com.
