THE WARRANTY

GAF warrants to you, the original owner of the property described above, that products sold under the StreetBond® brand (the "StreetBond® Products") will not contain a manufacturing defect that adversely affects performance for one year following the completion of installation on a sound pavement substrate, in accordance with the published application instructions for them and as long as the StreetBond® Products were installed during the shelf life set forth on the product label or container.

EXCLUSIVE REMEDY

GAF's sole responsibility for breach of this limited warranty is to provide replacement material for that portion of the StreetBond® Products that peel, delaminate, or show abnormal wear, or at GAF's sole option the cash value of said StreetBond® Products. Decisions as to the extent of replacement material required will be made solely by GAF. The remedy under this Limited Warranty is available only for that portion of the StreetBond® Products actually peeling, delaminating, or showing abnormal wear at the time of settlement. The replacement StreetBond® Products, as well as any remaining original StreetBond® Products, will be warranted only for the remainder of the original warranty period.

NOTIFICATION OF CLAIM

In the event that your StreetBond® Products peel, delaminate, or show abnormal wear, you **MUST** notify GAF in writing — either by email (preferred) at guarantee@laf.com or by postal mail to GAF Guarantee Services, One Campus Drive, Parsippany, NJ 07054 — **and** provide proof of purchase, lot numbers, and application date within **30 days** after your discovery of the issue. **NOTE:** Notice to your applicator or distributor is **NOT** notice to GAF. Within a reasonable time after proper notification, GAF will evaluate your claim and resolve it in accordance with the terms of this warranty. GAF may require you to submit, at your expense, samples of your StreetBond® Products for testing and photographs. You should retain this document in the event that you need to file a claim.

EXCLUSIONS FROM COVERAGE

This Limited Warranty does NOT cover damage to the StreetBond® Products resulting from anything other than an inherent manufacturing defect in the StreetBond® Products, including but not limited to:

1. Faulty application or application that is not in strict accordance with GAF's published application instructions such as improper preparation of the surface or inadequate provisions for curing prior to the surface being opened for use.
2. Exposure of the StreetBond® Products to damaging substances, such as chemical ice deterrent.
3. Settlement, movement, cracks, defects, or other failure of the pavement or surface over which the StreetBond® Products were applied.
4. Defects in the design or suitability of the pavement or surface over which the StreetBond® Products were applied.
5. Causes beyond normal wear and tear, such as unusual weather conditions or natural disasters, including but not limited to, windstorms, hail, floods, hurricanes, lightning, tornados, and earthquakes.
6. Impact of foreign objects or physical damage caused by any intentional or negligent acts, accidents, misuse, abuse, or the like including vandalism, tire scuffing, landscaping, snow removal equipment, and studded or traction tires.

This Limited Warranty MAY BE SUSPENDED OR CANCELLED IF THE STRUCTURE OR SURFACE IS DAMAGED BY any cause listed above as AN EXCLUSION FROM COVERAGE.

NON-ASSIGNABILITY

This Limited Warranty is NOT TRANSFERABLE OR ASSIGNABLE by contract or by operation of law, either directly or indirectly.

LIMITATION OF DAMAGES; MEDIATION; JURISDICTION; CHOICE OF LAW

THIS WARRANTY IS EXPRESSLY IN LIEU OF ANY OTHER WARRANTIES, EXPRESS OR IMPLIED, INCLUDING ANY IMPLIED WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE, and of any other obligations or liability of GAF, whether any claim against it is based upon negligence, breach of warranty, or any other theory. In NO event shall GAF be liable for any CONSEQUENTIAL OR INCIDENTAL DAMAGES of any kind, including, but not limited to, interior or exterior damages and/or mold growth.

The parties agree that, as a condition precedent to litigation, any controversy or claim relating to this warranty shall be first submitted to mediation before a mutually acceptable mediator. In the event that mediation is unsuccessful, the parties agree that neither one will commence or prosecute any lawsuit or proceeding other than before the appropriate state or federal court in the State of New Jersey. This warranty shall be governed by the laws of the State of New Jersey, without regard to principles of conflicts of laws. Each party irrevocably consents to the jurisdiction and venue of the above identified courts.

NOTE: Some states do not allow limitations on or the exclusion of incidental or consequential damages, so the above limitations or exclusions may not apply to you. This Limited Warranty gives you specific legal rights and you may also have other rights which vary from state to state.

EFFECTIVE DATE

This Limited Warranty is effective for StreetBond® Products installed within the United States, Canada, and Mexico after July 1, 2016.
