When your Timberline Solar® roofing system includes the required Timberline® shingles and approved GAF accessories—all installed by a GAF Energy Solar Certified Contractor¹—the system unlocks unparalleled warranty protection.

First, our GAF enhanced warranties — System Plus, Silver Pledge™, or Golden Pledge® — offer non-prorated coverage for qualifying GAF shingles and accessories

against manufacturing defects for 50 years (for single-family, individually owned detached residences). When the roofer installs GAF LayerLock®-labeled shingles with the required combination of at least four qualifying accessories, the shingles are also eligible for coverage under the 15-year WindProven™ Limited Wind Warranty, an industry-first limited wind warranty with no maximum wind speed limitation².

The addition of either the Solar Plus or Solar Max limited warranty addendums³ add coverage for the solar elements of your roof. Solar Plus offers coverage for electrical workmanship, energy generation, and coverage for the electronics and inverter for 10 years, and Solar Max increases those same coverages to 25 years.
