When installed by a GAF Metal Certified Contractor² and purchased with a TimberSteel™ ArmorPledge™ Limited Warranty¹, the TimberSteel™ system is backed by an unparalleled limited warranty, increasing the coverage period against manufacturing defects from a non-prorated coverage³ period of 15 years to 50 years⁴. It also covers tear-off and disposal costs.

Best of all, it provides 30 years of workmanship coverage against errors in the application of your GAF TimberSteel™ shingles, accessories, and covered flashings that might have been made during the original installation of your roof. Workmanship coverage is an important differentiator when choosing a residential roof warranty. Standard product warranties often include the labor required to repair or

replace a covered component due to any manufacturing defects, but do not cover misapplication.

Every GAF Metal Certified Contractor must be insured and licensed in states where they operate (if required).

After the Non-Prorated Coverage Period specified above, the remedy provided for in the applicable warranty will be reduced to reflect the use you have received from your TimberSteel™ System Components. The amount of use will be calculated by dividing the number of months which have elapsed since installation to the date of claim by the number of months in the warranty term. For a Lifetime warranty, GAF's contribution in years 51 and beyond is 20%. After the non-prorated period, GAF's maximum liability for any roof shall NOT exceed three times the reasonable cost of replacement TimberSteel™ System Components before any reduction for use.

⁴ 50-year non-prorated manufacturing defect coverage term applies only to single-family detached residences owned by individual(s). For all other properties, non-prorated manufacturing defect coverage term is 20 years.
